Teaching Experience

Courses Taught - Criminal Justice

- Common Academic Program Social Sciences (SSC 200), Fall 2022, University of Dayton, Dayton, OH. SSC 200 is a theme-based course that varies across sections but shares common learning outcomes. The course applies social science methods and social theory to critically examine human issues and problems from the perspective of three social science disciplines. The course emphasizes outcomes related to scholarship, critical evaluation of our times, and the diversity of the human world. This section is focused on connecting the criminal justice system and public health.
- Introduction to Criminal Justice Studies (CJS 101), Fall 2021, Fall 2022 and Spring 2022, University of Dayton, Dayton, OH.

 Introduction to the field of criminal justice studies, stressing the theoretical foundations, origin, nature,
 - methods, and limitations of criminal justice studies as a college curriculum.
- Introduction to Policing (CJ 210), Spring 2018 and Spring 2019, University of North Dakota, Grand Forks, ND.

 Undergraduate course in the Department of Criminal Justice that introduces students to the specific field of law enforcement agencies. Provides an overview of federal, state, and local law enforcement agencies. Reviews the coordination requirements of the system.

Courses Taught – Social Work

Generalist Human Behavior in the Social Environment I (SWK 501), Spring 2022, University of North Dakota, Grand Forks, ND.

Generalist Human Behavior in the Social Environment I (HBSE I) provides students with foundational knowledge relevant to human life span development, and an introduction to social work systems perspectives. Students critique and apply various frameworks to case scenarios that exemplify client differences in biological, psychological, social, spiritual, and cultural domains.

Generalist Practice with Treatment and Task Groups (SWK 434), Summer 2019, 2020, and 2021, University of North Dakota, Grand Forks, ND.

Undergraduate course in the Department of Social Work focusing on generalist practice with task and treatment groups within the context of evidence-based interventions. Encourage and foster the development of skills to engage, assess, plan, intervene, and evaluate social work practice with groups.

- Generalist Research Methods and Analysis (SWK 507), Spring 2020, University of North Dakota, Grand Forks, ND. This graduate-level introductory course provides students with foundational knowledge of research methods and analysis and prepares them for the development of advanced research skills. MSW students gain knowledge of the methods of scientific inquiry and how to construct and utilize evidence-informed research for practice. The course emphasizes ethical approaches to research and the effective communication of empirically based knowledge.
- Social Work Research & Program Evaluation I (SW6941), Fall 2021 and Summer 2022, Ohio University, Athens, OH. The purpose of this course is to provide graduate social work students with an understanding of research methods that social workers use to study effectiveness of their practice as well as build and expand knowledge for development and improvement of social work practice at all levels. In addition, the course requires the students to think of a researchable problem related to their field internship and write a research proposal as well as begin the application process to the Ohio University Institutional Review Board for approval of their proposal research.
- Social Work Research & Program Evaluation II (SW6942), Spring 2022, Ohio University, Athens, OH.

 During the course, students will learn statistical analyses including descriptive and inferential statistics to complete the proposed research project approved by OU IRB and/or ethical guidelines of conducting social work research. Students will complete collection of data, and analysis of data using selective procedures. Students will use the appropriate analysis skills to analyze data collected for their evaluative or explanatory projects. Students will get experience of presenting their study verbally to their peers and other academic visitors such as field instructors and faculty members as well as write a publishable manuscript using APA style.
