ONLINE ORDERING

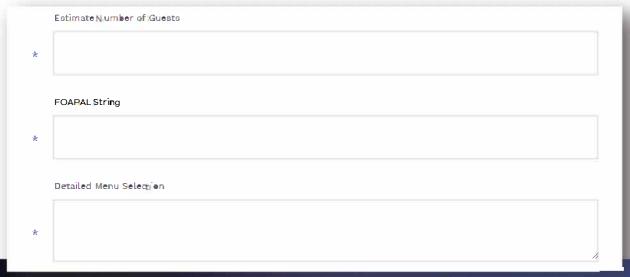


Figure 1: Catering online order form (new), selection including "FOAPALString" field

Prior to the Chart of Accounts changes, users would enter a funding source in the field labelled "Account Number". This field will be replaced with a field for FOAPAL input (see Figure 1).

INVOICES

Invoices will look slightly different for customers on campus. Old invoices contained information labelled "Billing Reference" that denoted a Chart D index number for billing. See Figure 2 (below) for an example.

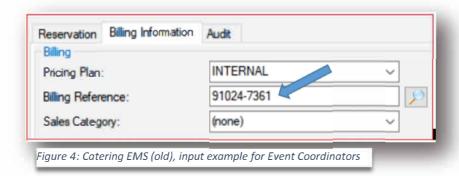
Figure 3: Catering Invoice (new), customer information, event details, and FOAPAL and Credit/Billing Account# information

Invoices will contain additional information after the Chart of Accounts (Chart F) changes. See Figure 3 (below) for a sample. In the sample, users will see the "Billing Reference" information removed and replaced with "Billing FOAPAL" and "Credit FOAPAL" information.

ORDER INPUT FOR EVENT COORDINATORS

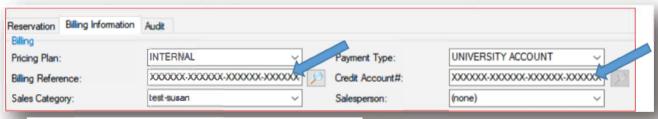


Figure 5: Catering EMS (new), input example for Event Coordinators

For employees working within the Catering Services department, event and billing information will now require FOAPAL string input for the "Billing Reference" and new "Credit Account#" fields. These strings are reflected in the customer invoice (in Figure 3). See Figures 4 and 5, (below) for details.
