

Article I: Name of the Association

The name of this association shall be the University of Dayton Sports Law Society. It may be abbreviated UDSLS.***(Amended October 10, 2004)

Article II: Objectives of the UDSLS

The objectives of the UDSLS shall be:

- a. To promote the study of the law as it relates to sports;
- b. To establish and maintain a forum for intelligent discussion of the law as it relates to sports; and
- c. To serve as a resource for professional legal opportunities related to sports.

Article III: Membership

Each person enrolled in the University of Dayton School of Law, as a candidate for the degree of Juris Doctor, expressing a genuine interest in the law as it relates to sports, shall be eligible for membership in the UDSLS.

- a. Eligible members must pay a fee for the Fall and Spring semester to be considered official members of the UDSLS.
- b. Fees will be determined each semester by the UDSLS officers (defined in **Article IV**).

Article IV: Officers

The following officers shall be elected by a majority of the voting members at the first meeting each academic year: President, Vice President, and Treasurer. Additional officers may be added to the UDSLS if deemed necessary by the elected officers or two-thirds of the voting members.

§1. The President shall:

- a. Coordinate UDSLS business and activities;
- b. Preside at all UDSLS meetings;
- c. Represent the UDSLS at all sponsored events and meetings outside the organization;
- d. Inform the UDSLS faculty sponsor of events and proceedings; and
- e. Delegate any necessary duties to UDSLS officers.

§2. The Vice President shall:

- a. Assist the President in conducting UDSLS meetings;
- b. Perform the duties of the President in the President's temporary absence;
- c. Assume the office of the President in the event of an indefinite or permanent vacancy;
- d. Attend and participate in all officer meetings; and
- e. Perform any other duties delegated by the President.

§3. The Treasurer shall:

- a. Keep all financial records;
- b. Manage the UDSLS account;
- c. Handle UDSLS funds;
- d. Attend and participate in all officer meetings; and
- e. Perform any other duties delegated by the President.

Article V: Amendments

§1. Amendments

- a. Amendments to the Constitution shall be proposed in writing by any member of the UDSLS.
- b. The proposed amendments shall be adopted by two-thirds of the UDSLS voting members.

AMENDMENT I

The organization shall now include the office of Secretary.

The secretary shall:

- a. Record minutes at all general member and officer meetings.
- b. Participate in all officer meetings.
- b. Perform any other duties delegated by the President.

AMENDMENT II

The name of the organization shall hereby be changed from the University of Dayton Sports Law Society to the University of Dayton Sports and Entertainment Law Society.
